If your pass is forgotten, you will receive one complimentary day ticket. After that, you must purchase a ticket.	Violation of Your Responsibility Code, rude or obnoxious behavior, jumping from the chair lift, accessing areas out of the ski area boundary, etc., may result in the loss of your season pass.
The replacement fee for a lost pass is \$10.	Passes are non-refundable.

VOLUNTARY WAIVER + RELEASE FROM LIABILITY

I do hereby agree to RELEASE, HOLD HARMLESS, DEFEND AND INDEMNIFY WGSKI, Inc., dba Ski Bluewood; their officers, managers, employees, instructors, agents, and sponsors from all liability or responsibility for any claim or damage arising from whatever cause, including negligence, from my participation while skiing, snowboarding or other snow sports, or using any other sliding device or any use of the facilities at Ski Bluewood. I understand that there are certain risks inherent in skiing and learning to ski; skiing is a dangerous activity that can cause severe injury or death. I understand and agree to assume all risks associated with skiing, and other snow sports, including but not limited to the risk of equipment failure, weather hazards, snow-related hazards, collisions with other people, equipment, or other objects located on the mountain and lift mishaps.

I hereby agree to the terms of this RELEASE and agree to assume all the risks of injury and ski or participate in other snow sports at my own risk. This RELEASE is intended to release any and all claims based on my participation while skiing, snowboarding, and other snow sports or using any other sliding device or any use of the facilities at SKI BLUEWOOD, regardless of whether the claims are brought by me or on my behalf. I understand that it is my responsibility to be aware of and obey Washington's Skier Law RCW 79.145 et seq. and Columbia County Washington Skier Safety Ordinance 90-4. If I am signing on behalf of a minor, I accept full responsibility for all medical expenses incurred due to the minor's participation in activities or travel to and from Ski Bluewood. I also agree to HOLD HARMLESS AND INDEMNIFY Ski Bluewood from any claims of any nature brought by or on behalf of the minor. In addition, I hereby waive all claims based upon injury or death of the minor, including but not limited to claims for loss of consortium or companionship.

I agree that any disputes related to this Agreement, any use of the Season Pass, or use of any SKI BLUEWOOD facilities will be brought to the Superior Court of Washington for Columbia County. Washington law will apply to any such disputes. The use of the term "skiing" also applies to snowboarding and the use of any other sliding device or equipment. I understand that Bluewood may use my photo or video for marketing and promotional materials for the ski area.
